




EVIDENCE OF ELDER ABUSE & PREVENTION

- □ Between 2015 January 2018 774 males and 383 females between the ages of 60 68 years old were victims of serious and violent crimes (Jamaica Constabulary Force Statistics and Information Management Unit, 2018).
- ☐ In 2015, 383 persons 65 years and older were victims of serious crimes. 256

were men (67%) and 127 (33%) were women (National Policy for Senior Citizens, 2018; ESSJ, 2015).

## **EVIDENCE OF ELDER ABUSE**& PREVENTION CONT'D

- □ Newspaper reports highlight elder abuse in care facilities (Jamaica Gleaner; Reid, 2011); neglect and financial exploitation by family members and strangers (Jamaica, Gleaner; Malcolm, 2017).
- ☐ Limitations no formal reporting system in place

- ☐ Elder abuse cases are underreported
- ☐ Limited resources and the absence of solid evidence deter the development of comprehensive prevention programmes (Pillemer et al. 2016).

THE EFFECT OF ELDER ABUSE ON OLDER PERSONS

- □Social isolation, fear and loneliness
- □ Psychological consequences including depression and anxiety.
- ☐Paranoia disorder
- □ Physical impairments -hospitalization depending on the severity of the injury; serious and permanent damages can result in death (WHO, 2020).
- □Low self-esteem

BERMUDA'S RESPONSE TO ELDER ABUSE THAT JAMAICA CAN ADOPT

- ☐Bermuda's current population: 62,090.
  - □54% Black, 31% White, 8% Multiracial, 4% Asian, 3% Other (2010 Census)
- □Bermuda Senior Abuse Register Act 2008
  - □ Legislated by the Queen's Most Excellent Majesty with the advice and consent of the Senate and the House of Assembly of Bermuda.
  - ☐ The Act protect seniors from abuse:
    - ☐ Establishes a register for persons who abuse seniors
    - ☐ Mandatory reporting of the abuse of seniors Ageing and Disability Services which is the Senior Abuse Registrar

BERMUDA'S RESPONSE TO ELDER ABUSE THAT JAMAICA CAN ADOPT CONT'D

- □Perpetrators who commit the offence charged a fine not exceeding \$10,000 (BMD) or imprisonment for a term not exceeding 3 years, or both.
  - □Offenders name are entered in the Register
  - □ Prohibited to work as a care provider or involved in managing the finances of older adults.
