

Waiver and Consent Form

1. Ownership of Winning Artwork

I acknowledge and agree that upon submission and/or selection of the Student’s artwork as a
winning entry, ownership of the winning artwork, including all intellectual property rights, shall
vest in the Ministry.

2. Use of Artwork

I grant the Ministry the right to reproduce, display, adapt, install and otherwise use the winning
artwork for non-commercial governmental purposes, including but not limited to use as murals
in schools and public buildings, exhibitions, educational materials and publications by the
Ministry in print and digital media.

3. Use of Photographs

I consent to the taking and use of photographs, video recordings and other images of the Student
and/or the Student’s artwork in connection with the competition and related activities, for non-
commercial governmental, educational and promotional purposes of the Ministry, including
publication in print and digital media.

4. No Payment

I acknowledge and agree that neither the Student nor I shall be entitled to any payment, compensation, fee, royalty, reward, benefit or consideration of any kind, whether financial or otherwise, arising from or related to:

- (a) the Student's participation in the competition; or
- (b) the submission, selection, ownership, display, reproduction or use of the artwork by the Ministry.

5. Acknowledgment

I understand that the Ministry may, at its discretion, acknowledge the Student and/or the Student's school in connection with the use of the artwork but is not obligated or required to do so.

6. Originality of Artwork

I confirm that the artwork submitted by the Student is original, was created by the Student and does not infringe the intellectual property or other rights of any third party.

7. No Obligation to Use

I acknowledge that submission of artwork by the Student does not guarantee selection, display or use by the Ministry.

8. Consent to Participation

I consent to the Student's participation in the competition and to the submission and use of the artwork in accordance with the objectives and terms of the competition as outlined out in the registration form.

9. Authority to Consent

I confirm that I am legally authorized to give this consent on behalf of the Student.
